SPEAKER INTRO: Sam

This afternoon, we welcome two members of the Lombardi Comprehensive Cancer Center's *Cancer Prevention and Control Program* at Georgetown University Medical Center, Dr. Kathryn Taylor and Dr. Randi Williams.

Dr. Taylor is a tenured Professor in the Department of Oncology whose recent research has focused on the clinical and public health translation of lung cancer screening as a teachable moment for smoking cessation and relapse prevention. Her team recently completed an NCI-funded randomized smoking cessation intervention trial among individuals who were undergoing lung cancer screening as well as an American Lung Association-funded randomized trial designed to improve awareness of lung cancer screening among individuals who contacted the Maryland Tobacco Quitline. As part of the NCI's Cancer Center Cessation Initiative, Dr. Taylor also leads the Smoking Treatment and Recovery Program at Georgetown Lombardi Comprehensive Cancer Center.

Dr. Williams is an Assistant Professor in the Department of Oncology, whose research focuses on methods to promote the adoption of evidence-based lung cancer control practices to advance health equity. In her NCI-funded award, Dr. Williams is targeting provider and patient behavior to promote communication and advance equity in screening rates between Black & White patients. She recently led the development of a self-directed *Health Disparities & Lung Cancer Screening* course for primary care providers and co-leads a DC Health Department-funded quality improvement initiative to address tobaccorelated disparities. She also co-leads the Dissemination & Implementation Affinity Group and serves on the *Racial Justice Committee for Change Curriculum: Reform Subcommittee* at Georgetown.

This afternoon, we welcome Ryan Coffman, who is the Tobacco Policy and Control Program Manager for the Philadelphia Department of Public Health. In this role, he oversees several tobacco control and policy initiatives within the Division of Chronic Disease and Injury Prevention. These initiatives include the prevention of youth initiation, promoting tobacco-free environments, mass media campaigns, tobacco control policy, and tobacco treatment services. He is committed to serving vulnerable populations disproportionately impacted by the effects of tobacco use.

Previously, Ryan provided inpatient, outpatient, and community tobacco use disorder treatment in hospital, behavioral health, correctional, and substance use treatment settings. He acquired his Masters in Public Health at Tulane University and has certifications in health education, tobacco use disorder treatment, and global tobacco control. Ryan first became committed to tobacco control in 2003 while serving as a Peace Corps volunteer in Kenya and continues to provide tobacco treatment services at Health Center 2 in South Philadelphia.
